## Fulton County Sheriff's Office: Tech Demo Day

Atlanta, GA – Fulton County Sheriff's Office invites journalists to attend a Tech Demo Day featuring innovative technology solutions aimed at improving jail operations and safety. During this event, journalists will have the opportunity to see live demonstrations of cutting-edge technologies from RaySecur, Note Active, Tek84, and Talitrix. We request that participating companies showcase their technology in real time.

Last month, the Board of Commissioners approved emergency funding to address urgent needs at the Fulton County Jail. Innovative technology initiatives were in progress, but this significant action provided a boost for the care and safety we provide to detainees and staff. This technology included:

• Implementation of the Talitrix system (<u>https://www.talitrix.com/</u>) in the medical and psychiatric observation units. The wearable technology allows biometric monitoring and automatically alerts medical and custody staff in the event of low blood pressure, elevated heart rates, or other medical complications.

• Additional cameras to provide real-time surveillance of movement within the jail, with specific emphasis on blind spots in the medical and mental health observation units. These cameras will soon have the capability to work in conjunction with the Talitrix wearable wristbands to automatically adjust the camera's view upon receiving emergency alerts from the wristband.

• RaySecur: 4D imaging of all incoming legal mail at the Fulton County Jail to detect the presence of narcotics.

• NoteActive: Tablet technology that has eliminated the use of logbooks and allows for real-time tracking of medical, food, or other contacts with inmates in real time.

• Tek84: Detects objects on or inside a person's body for security screening purposes, without physically removing clothes or making physical contact.
