### **FCSO Traffic Unit Seatbelt Violation Traffic Stop Results in Arrest for Drugs and Guns**

**ATLANTA, GA** – Nathaniel Streater, age 29, of Stone Mountain, GA, has been arrested and charged with the following:

- Possession of Firearm or Knife During Commission of or Attempt to Commit Certain Felonies (2 counts)
- VGCSA – Possession of Controlled Substance in Schedule I or II with Intent to Distribute (1 count)
- VGCSA – Purchase, Possess or Have Control of Controlled Substance in Schedule I or II (1 count)
- Possession and Use of Drug Related Object (1 count)
- Giving False Information to Law Enforcement Officer (2 counts)
- Driving – Possession of Open Alcohol Container (2 counts)
- Driving While License Suspended or Revoked (1 count)
- Seatbelt Violation – Adult (1 count)
- Driving – Defective or No Taillights (1 count)

On Friday, February 21, 2025, a Fulton County Sheriff's Office Deputy assigned to the Traffic Unit conducted a traffic stop in Atlanta, GA, on a car where he saw the male driver not wearing a seatbelt. When the deputy asked the driver for his name and driver's license, he stated he did not have his driver's license on him, and during the stop he provided the deputy with two different names and said he was from California. As the man was being detained, the deputy detected a strong odor of marijuana coming from the car. A probable cause search resulted in the seizure of several bags containing suspected marijuana totaling 96.1 grams, a bag containing several pills (suspected MDMA), a scale, a box of clear bags, two open bottles of tequila, a Glock handgun, and a Kel Tec rifle.

Streater was positively identified once booked into the Fulton County Jail.

"I want to commend our Traffic Unit for their keen observation and swift action while patrolling the streets of Fulton County. This arrest highlights the critical role our team plays in enhancing public safety," says Sheriff Patrick "Pat" Labat. "We will continue to serve as a force-multiplier for our law enforcement partners in Fulton County, working together to ensure the safety and security of all our citizens."
