FCSO Arrests Burglary Suspect Wanted out of Brookhaven

Atlanta, GA – The Fulton County Sheriff's Office, Strategic Enforcement Unit, Fugitive Apprehension Support Team (FAST) arrested Amanda Noble, age 44, of Atlanta. She is currently in the Fulton County Jail.

A FAST unit was conducting a crime suppression patrol and received an alert of a stolen van last seen in Clayton County. Shortly thereafter, a van matching the description passed his location. Upon attempting to verify the license plate, Inv. Moore initiated a traffic stop. The van sped away resulting in a pursuit. The van turned down a dead end street and crashed. Both occupants of the van ran from the scene. The driver, later identified as Donald Johnson, got away. The passenger was identified as Amanda Noble.

Noble was wanted for numerous offenses in Brookhaven, GA. She now faces two counts of willful obstruction of law enforcement officers – misdemeanor, one count of theft by receiving stolen property - felony, and one count of VGCSA – possession of controlled substance in schedule I or schedule II with intent to distribute.

Arrest warrants for Donald Johnson, age 47, have been obtained for one count each: attempting to misrepresent tag, possession of marijuana, less than one ounce, VGCSA – Possession of controlled substance in schedule I or schedule II with intent to distribute, willful obstruction of law enforcement officers – misdemeanor, driving – hit and run, fleeing or attempting to elude a police officer during the commission of certain crimes, reckless driving, and theft by receiving stolen property – felony.

"I am proud of the women and men of the Fulton County Sheriff's Office who are committed to fighting crime within Fulton County," said Sheriff Patrick "Pat" Labat. "FCSO law enforcement assets patrolling the streets of Fulton County have proven effective in getting bad actors off the street, from fugitives to impaired drivers. We remain dedicated to keep our communities safe."

If anyone has information about this incident and/or the whereabouts of Donald Johnson and wants to report it anonymously, they can submit a tip through the Crime Stoppers platform. If the tip leads to an arrest, the tipster may be eligible for up to a \$5,000 reward. NO REPORTS, NO COURT, NO NAMES.
